Modified Operations in Response to COVID-19

We appreciate your patience, understanding, and cooperation as we work together as a community to deal with the spread of COVID-19. The Weber County Clerk/Auditor's Office strongly encourages waiting until restrictions have been reduced before coming into the office in person. **Front Counter**

Our front counter staff interact with the public more than any other Clerk/Auditor department, and the majority of those we serve are especially vulnerable to COVID-19. We recognize that adjusting these operations will have a significant impact on our citizens, but will also help to address the greatest risk to both our staff and the public spread of the virus.

**Marriage License**

You can schedule an appointment to receive a marriage license. Note that Utah County also offers the ability to obtain a marriage license online. You may learn more about that service here:

If you need to return a marriage license, you may either mail it to us, or use the drop box located in the lobby of the Weber Center.

**Passports**

Our passport processing operations are severely limited, and the Department of State has also been affected. If you have a pressing need, with a definite time and location for travel, please contact our office for an appointment. Otherwise, please wait until we have resumed normal operations.

You may contact the Post Office or other passport acceptance facilities to check on passport availability through their location.

**Tax Relief**

There is no need to deliver your tax relief application in person. You may mail your tax relief application and supporting documents, or place them in the drop box located in the lobby of the Weber Center. Please call if you have questions about your tax relief application.

**Veteran Vehicle Registration**

For those under the Veteran with a Disability tax relief program, please plan to register your vehicle first and then bring in your registration information for reimbursement after we resume normal operations. If this will cause a hardship for you, please call us to discuss options.

**Tax Sale**

Our preparations for the 2020 Tax Sale will continue, including mailing notices to affected property owners. Our tax sale staff is available by phone and email.

### **Property Appeals**

Our Board of Equalization section will still be available by phone and email, and you may mail your property appeal to us as usual.

### **Tax Exempt**

Tax Exempt entities may still contact us by phone and email, and you may mail your tax exempt application to us as usual.

### **Comptroller/Budget/Accounts Payable**

Our Accounting office is still operating as usual. They are available via phone and email.
