



NOTARIZED MARRIAGE LICENSE INFORMATION FORM – SPOUSE ABSENT

PLEASE READ CAREFULLY

These instructions must be followed exactly to obtain a marriage license where one spouse cannot be present at the time of application. **This form is for the absent spouse only. The other spouse must be present.**

1. All personal data, **except signature**, must be completed in ink before the document is notarized.
2. This form must be **signed in the presence of a notary**, who will verify the identity of the person signing.
3. The **spouse who will appear in person** must complete a separate marriage license application and must provide a copy of the absent spouse's photo ID with signature.
