Under the general guidance and direction of the Special Events Manager, will assist in the coordination of the Weber County Fair and all special events sponsored or co-sponsored by Weber County.

MAJOR DUTIES (Any one position may not include all of the duties listed, nor do the listed examples include all duties which may be found in positions of this class.) Adheres to policies and procedures as set forth by the Weber County Commission. Prepares contracts, invoices, collects fees, develops layout and schedules commercial vendors for events. Takes minutes at monthly Fair Board meetings and keeps official records and reports. Assists in coordinating advertisements for the Weber County Fair premium book and sponsors for the Weber County Fair. Works with facilities crews on coordinating electrical, water and clean-up needs. Attends job-related conferences and meetings. Develops sponsorship packages and works with businesses and the community for sponsorship monies toward the Weber County Fair. The sponsorship program includes preparation of contracts and proposals. Distributes advertising material. Attends events, both daytime and evenings, seven days a week, when nature of the event warrants the Special Events Coordinator's presence. Prepares Weber County Fair evaluation summaries. May assist with special projects, as assigned. Performs other work as assigned.

MINIMUM QUALIFICATIONS *Two years of college or university course work in business administration, public relations, political science, marketing, communications or a related field. AND Two years of experience in employee supervision, administration and/or finance. OR Any equivalent combination of education and experience.*

Considerable knowledge of modern office practices and procedures; knowledge of effective supervisory techniques; knowledge of grounds facilities. Skill in the use of computer; skill in typing at a rate of 40 words per minute; skill in public relations. Ability to establish and maintain effective working relationships with employees, other agencies, and the public in a courteous, cooperative, and professional manner; ability to communicate effectively both verbally and in writing.

SPECIAL QUALIFICATIONS *Must be adaptable to changing work hours as hours may vary depending on scheduled events. Must be able to work evenings, weekends and holidays. Must be on-call 24 hours, one week prior and during the Weber County Fair. Must have a valid Utah Driver's License and a good driving record.*

TOOLS AND EQUIPMENT USED Phone; personal computer; copy machine; fax machine; 10-key; mobile or portable radio.

PHYSICAL DEMANDS The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job.
