NOTICE OF PROPOSED TAX INCREASE

Weber County

The Weber County is proposing to increase its property tax revenue.

- The Weber County tax on a \$199,000 residence would increase from \$300.22 to \$375.27, which is \$75.05 per year.
- The Weber County tax on a \$199,000 business would increase from \$545.86 to \$682.31, which is \$136.45 per year.
- If the proposed budget is approved, Weber County would increase its property tax budgeted revenue by 25.00% above last year's property tax budgeted revenue excluding new growth.

All concerned citizens are invited to a public hearing on the tax increase.
