NOTICE OF PROPOSED TAX INCREASE WEBER BASIN WATER - OGDEN LEVY APPLICABLE TO OGDEN CITY RESIDENTS & BUSINESSES ONLY

The WEBER BASIN WATER CONSERVANCY DISTRICT, at the request of OGDEN CITY to collect payments for its water purchase contracts, is proposing to increase its property tax revenue.

- The WEBER BASIN WATER OGDEN LEVY tax on a \$224,000 residence would increase from \$31.54 to \$39.42, which is \$7.88 per year.
- The WEBER BASIN WATER OGDEN LEVY tax on a \$224,000 business would increase from \$57.34 to \$71.68, which is \$14.34 per year.
