

**NOTICE OF PROPOSED TAX INCREASE  
COUNTY OF WEBER**

The COUNTY OF WEBER is proposing to increase its property tax revenue.

- The COUNTY OF WEBER tax on a \$366,000 residence would increase from \$435.21 to \$454.79, which is \$19.58 per year.
- The COUNTY OF WEBER tax on a \$366,000 business would increase from \$791.29 to \$826.89, which is \$35.60 per year.
- If the proposed budget is approved, COUNTY OF WEBER would increase its property tax budgeted revenue by 4.50% above last year's property tax budgeted revenue excluding eligible new growth.

**NOTICE OF PROPOSED TAX INCREASE**  
**Central Weber Sewer Improvement District**

The Central Weber Sewer Improvement District is proposing to increase its property tax revenue.

- The Central Weber Sewer Improvement District tax on a \$385,000 residence would increase from \$106.51 to \$127.05, which is \$20.54 per year.
- The Central Weber Sewer Improvement District tax on a \$385,000 business would increase from \$193.66 to \$231.01, which is \$37.35 per year.
- If the proposed budget is approved, Central Weber Sewer Improvement District would increase its property tax budgeted revenue by 19.28% above last year's property tax budgeted revenue excluding eligible new growth.

## **NOTICE OF PROPOSED TAX INCREASE WEBER FIRE DISTRICT**

The WEBER FIRE DISTRICT is proposing to increase its property tax revenue.

- The WEBER FIRE DISTRICT tax on a \$483,000 residence would increase from \$324.36 to \$356.67, which is \$32.31 per year.
- The WEBER FIRE DISTRICT tax on a \$483,000 business would increase from \$589.74 to \$648.49, which is \$58.75 per year.
- If the proposed budget is approved, WEBER FIRE DISTRICT would increase its property tax budgeted revenue by 9.96% above last year's property tax budgeted revenue excluding eligible new growth.
