Summary:

The parcel of land, identified as Tax ID #16-049-0130, was acquired by the County through a tax sale process and deed executed in 2012. This undeveloped parcel contains approximately 4.19 acres, has a market value of \$167,600.00, and lies northeasterly of residences that front on Mountain Road at approximately 3200 North, in North Ogden City. See Attachment A for a vicinity map and Attachment B for a Recorder's Office Plat Map.

Weber County has no intended use for the property; therefore, it is recommended that the parcel be declared as surplus and offered to North Ogden City. In order to convey real property, the County Commission must first take action to review and officially declare parcels as surplus to the County's needs.


