

**THIRD AMENDMENT
TO
MASTER SERVICES AGREEMENT**

This **THIRD AMENDMENT** ("Third Amendment") is effective as of the last date signed by either party ("Third Amendment Effective Date") and amends and supplements that certain Master Services Agreement by and between Securus Technologies, LLC ("we," "us," or "Provider") and the Weber County Correctional Facility ("you" or "Customer") dated July 14, 2017, as subsequently amended (collectively, the "Agreement").

WHEREAS Customer and Provider are parties to the Agreement and desire to amend the terms as stated herein;

NOW, THEREFORE, as of the Third Amendment Effective Date and in consideration of the mutual promises and covenants contained herein, the parties agree as follows:

- Term. This Third Amendment shall commence on the Third Amendment Effective Date and shall remain in effect through the Term of the Agreement. Notwithstanding anything to the contrary, the terms and conditions of the Agreement shall continue to apply for so long as we continue to provide the Applications to you after the expiration or earlier termination of this Agreement.
- Lexipol PoliceOne and CorrectionsOne. Provider will deploy Lexipol's PoliceOne and CorrectionsOne products. Customer's use of these products is also governed by and conditioned upon acceptance of the Lexipol End User Agreement, which will be provided to Customer. The obligations set forth therein are in addition to and not in lieu of the terms and conditions in this Agreement. In the event of a conflict in this Agreement and the terms of the Lexipol End User Agreement, the Lexipol End User Agreement will prevail. Customer will owe Provider the compensation described in the table below, which will be invoiced to Customer at the beginning of each applicable period in the table.¹ Invoices are due and payable within 30 days and Provider reserves the right to deduct any unpaid invoices from compensation otherwise owed to Customer under the Agreement.
