Jo ACTOR COMPENSATION: Actors will receive a stipend of \$75 per show, for a total compensation of \$375 to be paid at the close of the final performance listed above. This compensation is contingent upon the actor being present at all required rehearsals & performances.

Jo COMP TICKETS: Actors will receive TWO complimentary tickets for **Secret Garden** which can be used at any one performance. Contact the theater box office to select your show date/seats.

Jo MEDIA RELEASE: I, the undersigned, hereby authorize Ogden Musical Theatre to photograph me, take motion pictures of me, take video footage of me, and/or make electronic sound recordings of me (herein referred to as photographic or electronic reproductions). 
