NB REHEARSALS: Be on time for rehearsals. You will be given a complete rehearsal schedule and notified in advance of any changes. If you are going to be late or are experiencing an emergency or sudden illness that prohibits you from attending, please contact your stage manager. (Contact information provided on the cast list.)

NB REHEARSALS will take place at the following location(s) and it will be clearly stated if a different location is needed.

- Ogden Eccles Conference Center: 2415 Washington Blvd. Ogden, Utah 84401

NB CONFLICTS: All conflicts have been correctly listed on the audition calendar (form). Conflict updates must be reported to the stage manager by the end of the first cast read-through. Any additional conflicts after this time may not be honored and may result in decreased payment.

NB PERFORMANCES: *Secret Garden* will perform at Peery's Egyptian Theater on the following dates: ATTENDANCE AT THESE IS MANDATORY!

- February 20th – 22nd – Dress Rehearsal
- February 23rd – **Opening Night!**
- February 24th – Evening Show
- February 25th – Matinee & Evening Shows
- February 26th – **Closing Night!**

NB CALL TIME: I am aware that I must arrive at the theater no later than 60 minutes before curtain.

NB ACTOR COMPENSATION: Actors will receive a stipend of \$75 per show, for a total compensation of \$375 to be paid at the close of the final performance listed above. This compensation is contingent upon the actor being present at all required rehearsals & performances.

NB COMP TICKETS: Actors will receive TWO complimentary tickets for **Secret Garden** which can be used at any one performance. Contact the theater box office to select your show date/seats.

NB MEDIA RELEASE: I, the undersigned, hereby authorize Ogden Musical Theatre to photograph me, take motion pictures of me, take video footage of me, and/or make electronic sound recordings of me (herein referred to as photographic or electronic reproductions). I authorize the use of any such photographic or electronic reproductions of me for any purpose, including but not limited to educational and other public media as may be deemed appropriate by Ogden Musical Theatre.

NB APPEARANCE: Dramatic changes to your look are not permitted without prior written consent from the production team. This includes hair cutting/color changes, tattoos, piercings, tan lines, or significant weight changes.
