

ORDINANCE NO. _____

AN ORDINANCE OF WEBER COUNTY AMENDING CERTAIN FEES TO THE WEBER COUNTY CLERK/AUDITOR’S OFFICE

WHEREAS, the Board of County Commissioners has received a request from Weber County Clerk/Auditor’s Office to add and amend certain fees approved through enactment of a county ordinance; and

WHEREAS, the Weber County Clerk/Auditor’s Office has provided information to justify those fees such that the Commission finds that the fees are reasonably related to the costs involved in providing said services; and

NOW THEREFORE, the Board of County Commissioners of Weber County ordains as follows:

Title 16, Chapter 2, of the Weber County Fee Schedule, shall be amended in-part to include the updated fees:
