EXHIBIT A

PROPOSAL ADDITIONAL MASTER PLAN SERVICES



Victus Advisors, Think Architecture, and Construction Control Corporation (CCC) will provide Weber County with additional services related to master planning for the future of the GSEC/Fairgrounds. Our proposed additional scope of work is detailed below:

PHASE 1 - UPDATE MASTER PLAN & FINANCIAL OPERATIONS ANALYSIS

- Think Architecture will update the Master Plan for the GSEC/Fairgrounds based upon the long-term vision/goals for the facility defined above.
- CCC will update the construction cost estimate to align with the updated Master Plan.
- Victus Advisors will update the Usage Estimates & Operating Pro Forma to align with the updated Master Plan.

 - o Professional Service Fees \$15,000

PHASE 2 - ECONOMIC & FISCAL IMPACT ANALYSIS

- If desired, Victus will develop an economic and fiscal impact analysis (via the IMPLAN system) associated with the updated master plan and operating pro forma. We will assess impacts on Weber County in terms of direct spending, total economic output (direct + indirect/induced), jobs, wages, overnight visitors, sales taxes, hotel taxes, food and beverage taxes, etc.
 - o Estimated Timeline 3 weeks
 - Professional Service Fees \$7.500
 - o Purchase of Weber County IMPLAN Data (at cost) \$3,500
