Dear President Bach:

As County Commissioners for Weber County, we wholeheartedly support the efforts of the Salt Lake City-Utah Committee for the Games to host a future Olympic and Paralympic Winter Games here in Utah. On behalf of our residents, we are grateful for the consideration of the International Olympic Committee to host a future Games in Utah.

Hundreds of our residents participated in the Salt Lake 2002 Olympic and Paralympic Winter Games. By every measure the Games were an incredible success. Thousands of our residents, along with visitors from around the world, had an opportunity in 2002 to see the world's best athletes compete in curling at the Weber County Sports Complex (WCSC) and in downhill and super-G alpine at Snowbasin.

Since that time, Weber County has been fully committed to sustaining and building on the legacy of the Games. WCSC is a central gathering place for our community and is used today by our residents and visitors alike, along with world-class athletes. Looking ahead to a future Games in Utah, we signed in 2022 the venue use agreement for the WCSC to host events, and fully support the Games concept which also includes alpine events to be held in Snowbasin.

Weber County is once again ready to welcome the world. There is consistent, overwhelming public support in our county for the Olympic and Paralympic Movement. Many in our county were blessed with incredible opportunities in 2002 to develop skills, experience and relationships - as volunteers, staff, contractors and partners - that have enabled Weber County and the State of Utah to host more than 900 national and international sport competitions in the past 20 years. Together, we stand ready to organize a future Games in Utah that will elevate winter sport, our community and the Games experience.

To ensure the Games will be delivered successfully, as County Commissioners of Weber County, we hereby guarantee the support of Weber County in respect of:

- non-discrimination towards persons with reduced mobility; that national and international accessibility standards will be applied for the Games and that accessibility will be fully integrated into the planning and construction phases of any new venue (G1.3);
- the delivery of (i) power, (ii) telecommunications infrastructure, (iii) fixed and mobile telecommunication capacity as well as (iv) frequencies, in an appropriate level and quality to meet the needs of the Olympic Games, accompanied by corresponding support services (G1.5);
- the secure and peaceful celebration of the Games, and to provide all the required services to this effect, including to efficiently prevent and address any type of security threats related to the Games, including with regard to physical and cyber security (concerning without limitation accredited persons and all Games-related information and telecommunication services and infrastructure); and to cooperate with the Organizing Committee for the Olympic Games (OCOG) and the IOC on security



matters, including by sharing with the IOC the necessary information, according to the allocation of responsibility outlined in the Salt Lake City-Utah Preferred Host Submission (G1.9);

- the protection of the health and safety of Games participants, media, other accredited persons and spectators (including in case health and safety are threatened due to a pandemic or other major health crisis, terrorism or other forms of violence, natural disaster or any other cause of major importance); Weber County's responsibility for all aspects of medical and health services related to the Games; and the ability for team physicians to treat their national delegation within Weber County if necessary during the period of the Games (G1.10);
- public services Weber County generally provides the public, with the OCOG only held responsible to pay for incremental costs directly associated with planning and delivering the Games (G1.11);
- the protection of Olympic Properties in the host country through adequate and continuing legal protection of Olympic Properties within Weber County in the name of the IOC; appropriate legislation to ensure protection of the IOC's rights and interests in relation to the Games (such as, without limitation, regarding protection against unauthorized street trading, unauthorized ticket resale, unauthorized live sites and public viewing events, unauthorized broadcast or retransmission of Games images, ambush marketing and counterfeit merchandise; and securing of advertising space); and procedures and remedies allowing for timely resolution of disputes (G3.1);
- binding options from relevant third parties (public or private) for the acquisition of all existing or hereafter developed outdoor advertising space (e.g. billboards) including i. at any premises of the sites at which competitions or official events and activities of the Games will be held as well as any neighboring land and facilities up to five hundred meters in and around the perimeter of such sites; and ii. on public transport (e.g. buses, metro, trams, etc.) and adjacent parking facilities in the Host City/Region and in cities/regions having an operational role in the staging of the Games (e.g. venue cities, ports of entry, transport hubs, including indoor or outdoor advertising at airports) (G3.2);
- the respect of Olympic Charter, including the IOC Code of Ethics in all activities related to the organization of the Games, acknowledging of the prohibition of any form of discrimination with regard to a country or a person on grounds of race, color, sex, sexual orientation, language, religion, political or other opinion, national or social origin, property, birth or other status (G5.2.i);
- the assurance that human rights shall be protected and respected in all activities related to the organization of the Games. Any violation of human rights will be remedied in a manner consistent with international agreements, laws and regulations applicable within Weber County, and in a manner consistent with all internationally recognized human rights standards and principles, including the United Nations Guiding Principles on Business and Human Rights, applicable within Weber County (G5.2.iv);
