# Weber County – 12<sup>th</sup> Street Corridor, Segment 4 Change Order 6

During the final project walkthrough, there were a few locations that the designed drainage needed to be adjusted to accommodate the final grading and existing conditions. The drainage catch basins were installed as designed so these adjustments are additional work to get the drainage to flow more efficiently and to mitigate potential flooding of the surrounding properties. This change order is to cover the costs of these additional drainage items to improve the overall drainage along the corridor. There are also utility access concerns due to the new higher grade of the shoulders. This change order is to also adjust some of the utilities impacted by the higher grade change in the roadway.

The following items are being added to the contract.

Add Items:	84	Raise 4' x 4' box and extend 12" pipe
	85	Raise 4' x 4' box and extend 18" pipe
	86	Raise 4' x 4' box and extend 24" pipe
	87	Raise 3' x 3' box and extend 18" pipe
	88	Raise 3' x 3' box and extend 24" pipe

These pay items are to raise low catch basins at various locations throughout the project to grade and extend a new pipe out to capture storm drain water in the existing low spot on the shoulder. These pay items will cover all the labor, materials and equipment necessary to raise the catch basins and extend pipes out to the low spots. The contractor has submitted prices for each size of box and pipe to do this additional drainage work. The contractor's cost are shown on the table below and in Exhibit A. Independent costs analysis for each box and pipe size were conducted by the engineer to verify the contractor's pricing. The engineer's cost analyses were conducted utilizing UDOT average unit bid pricing from similar work and original bid item pricing. The engineer's cost estimate totals are shown in Exhibit B.

#### Add Item: 89 Raise Meter Box Only

There are a few water meter boxes that were buried by the fill placed for the higher grade and shoulder build out of the roadway. There are 2 of them that just need the boxes to be raised to grade to be able to access the valves. This pay item this to cover all the labor, materials and equipment necessary to raise the existing meter boxes to grade. The contractor has submitted a price of \$525.00 to raise each meter box to grade. The contractor's costs are shown on the table below and in Exhibit A. An independent cost analysis was conducted by the engineer to verify the contractor's pricing. The engineer's cost analysis was conducted utilizing UDOT average unit bid pricing from similar work. The engineer's cost estimate came to a total of \$797.71 per meter box and is shown in Exhibit B.

#### Add Item: 90 Raise Meter Box and Setter

There are a few water meter boxes that were buried by the fill placed for the higher grade and shoulder build out of the roadway. There are 2 of them that need both the boxes and setters raised to grade to be able to access the valves. This pay item is to cover all the labor, materials and equipment necessary to raise the existing meter boxes and setters to grade. The contractor has submitted a price of \$840.00 to raise each meter box and setter to grade. The contractor's cost are shown on the table below and in Exhibit A. An independent cost analysis was conducted by the engineer to verify the contractor's pricing. The engineer's cost analysis was conducted utilizing UDOT average unit bid pricing from similar work. The engineer's cost estimate came to a total of \$1,233.34 per meter box and setter and is shown in Exhibit B.

Add Item: 91 Relocate Meter Box

There are a couple of water meter boxes that need to be relocated further away from the roadway due to the proximity to the roadway, driveways and drainage channel. This pay item is to cover all the labor, materials and equipment necessary to relocate these meter boxes to a better location. The contractor has submitted a price of \$2,100.00 to relocate each meter box. The contractor's costs are shown on the table below and in Exhibit A. An independent cost analysis was conducted by the engineer to verify the contractor's pricing. The engineer's cost analysis was conducted utilizing UDOT average unit bid pricing from similar work. The engineer's cost estimate came to a total of \$3,025.00 per meter box and is shown in Exhibit B.

#### Add Item: 92 Fix Headgate & Grate

A new catch basin was added to the project and installed at 170+00 to connect the existing irrigation line to the new irrigation crossing. This was done to create a safer connection just off the roadway. The existing headgate was reinstalled but doesn't function properly to control the flow of water. This pay item is to cover all the labor, materials and equipment necessary to adjust the headgate to better control the flow of water and to cut a hole in the box grate to allow the gate to be controlled without having to remove the grate. The contractor has submitted a price of \$1,575.00 to make these adjustments to the headgate and grate. The contractor's costs are shown on the table below and in Exhibit A. An independent cost analysis was conducted by the engineer to verify the contractor's pricing. The engineer's cost analysis was conducted utilizing UDOT average unit bid pricing from similar work. The engineer's cost estimate came to a total of \$1,546.75 to make these adjustments to the irrigation and is shown in Exhibit B.

#### Add Item: 93 Tie West Warren Water Into Box

West Warren Water installed their detention basin to control discharge from their water plant, and this project was to connect into that basin as part of the agreement when the detention basin was constructed. This pay item is to cover all the labor, materials and equipment necessary to core into each box and run new pipe to tie the detention basin into the new storm drain system. The contractor has submitted a price of \$3,150.00 to make the connection. The contractor's costs are shown on the table below and in Exhibit A. An independent cost analysis was conducted by the engineer to verify the contractor's pricing. The engineer's cost analyses were conducted utilizing independent unit bid pricing from similar work and original bid item pricing. The engineer's cost estimate came to a total of \$1,233.34 per meter box and setter and is shown in Exhibit B.
