Memorandum of Understanding

Between Davis County and Weber County Animal Services

This memorandum is between Davis County (the "County"), a political subdivision of the state of Utah, and the following person or entity (the "Organization"):

The purpose of this Memorandum of Understanding ("MOU") is to establish a working relationship between the Organization and the County in preparing for and responding to disasters at all levels. This agreement provides a framework for cooperation between the two parties in rendering assistance and service to animals in the event of an emergency or disaster.

Services Provided

The Organization agrees to provide the following equipment and/or services below to aid the County when assisting animals in need:

- Provide the following equipment and/or services listed on Exhibit A at the time of an emergency or disaster.
- Provide updated contact information to keep our resource list current.
- The Organization will either use their own equipment and assist, or provide authorization for the County to use their equipment.

Methods of Cooperation

The Organization agrees to provide equipment depending on availability, if requested by the County during times of emergency or disaster. The Organization is not required to provide assistance if they determine they do not have sufficient resources to do so at that time.

Insurance Coverage

The Organization shall be responsible for their own actions or omissions and those of their employees and associates. The Organization shall be individually responsible for providing the insurance coverage for their business, employees or themselves as required by Utah law.

The Organization is expected to maintain their own equipment in a safe and operational condition, and to have current inspections, insurance, and paperwork on said equipment as may be required by law or regulation.

Periodic Review

Representatives of the Organization and the County will, on a bi-annual basis, on or around the anniversary date of this agreement, jointly evaluate and update this MOU if needed.

Term

This MOU shall commence once signed by both Parties and remain effective until canceled by either Party. It is understood by both parties that this MOU may be terminated at any time by giving 30 days written notification from either party.

Miscellaneous

Nothing in this MOU shall be construed as creating a relationship of employer and employee, or principal and agent, partnership or joint venture and in no way shall any individual of the Organization be considered an employee of the County. Nothing in this agreement shall be so construed as to provide either party with the authority to bind the other to any agreement, undertaking, cost, liability, or expense of any nature without the express written consent of the other.

Neither party shall be entitled to any rights of possession, custody, ownership, or control, either expressed or implied, of the tangible resources provided by the other party.
