

AMENDMENT TO SUBRECIPIENT AGREEMENT FOR
AMERICAN RESCUE PLAN ACT SLFRF FUNDS

Broadband Upgrade

This Amendment to Subrecipient Agreement ("Amendment") amends the "Subrecipient Agreement for American Rescue Plan Act SLFRF Funds" ("Original Agreement") between the County of Weber, Utah (the "County") and Ogden Nature Center (the "Subrecipient"), individually referred to as "Party" and jointly referred to as "Parties," which the Parties fully executed on or about August 9, 2022. The purpose of this Amendment is to increase the amount of SLFRF funding provided by the County to the Subrecipient.

WHEREAS, Subrecipient was awarded \$25,000 in SLFRF funds for an eligible Project, which is more fully described in Exhibit A of the Original Agreement; and

WHEREAS, Section 1, Paragraph B of the Original Agreement provides:

"In no event shall a revision to the scope of the Project entitle the Subrecipient to an additional allocation of SLFRF funds by the County unless Subrecipient makes a request to the County for additional funds. The Weber County Commission, in its sole discretion, may approve and authorize additional SLFRF funds for the Project."

WHEREAS, Subrecipient requested an additional \$7,356 in SLFRF funds from the County for the Project; and

WHEREAS, the County has determined that the Project remains an eligible use of SLFRF funds under ARPA and the Final Rule; and

WHEREAS, the County has awarded the Subrecipient additional SLFRF funds in the amount of \$7,356, for a total Award of \$32,356, subject to the County and the Subrecipient entering into this Amendment.

NOW, THEREFORE, for the mutual promises set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by each Party hereto, the Parties hereby agree as follows:

1. RECITALS AND DEFINED TERMS

- A. The above recitals are incorporated into, and made a part of, the Original Agreement.
- B. All capitalized terms not defined in this Amendment shall have the meanings assigned to them in the Original Agreement.

2. AMENDMENTS

- A. The amount of the Award in the Original Agreement is amended to \$32,356.

3. NO FURTHER MODIFICATIONS.

- A. Except as modified by this Amendment, the remaining terms and conditions of the Original

Agreement remain unmodified and in full force and effect, and the Parties hereby ratify all other provisions in the Original Agreement.


