**AN ORDINANCE OF WEBER COUNTY AMENDING
THE WEBER COUNTY FEE ORDINANCE**

WHEREAS, the Utah State Legislature passed HB 206 Bail and Pretrial Release Amendments which went into effect on October 1, 2020; and

WHEREAS, two of the pretrial release programs that are managed by the Weber County Sheriff's Office are being directly impacted by the requirements of the new law; and

WHEREAS, the Sheriff's Office has requested the additional portable breathalyzer and urinalysis fees listed below to help offset the costs of implementing the new law; and

WHEREAS, the Sheriff's Office no longer collects pay for stay restitution they ask that said fee be removed from the fee schedule; and

WHEREAS, the costs associated for inmate visits, emails and phone calls are managed by contracted providers, the Sheriff's Office asks that these fees be removed from the fee schedule; and

WHEREAS, the Sheriff's Office has purchased live scan fingerprint equipment, the Sheriff's Office requests modification of these fees to help offset the costs of the live scan equipment; and

WHEREAS, the writ of restitution services require more than deputy, the Sheriff's Office requests modification of that fee to help offset the costs of that service;

NOW THEREFORE, the Board of County Commissioners of Weber County ordains as follows:

Title 16, Chapter 2, of the Weber County Fee Ordinance, shall be amended in-part as follows:
