**Summary:** This ordinance accomplishes the following purposes in amending Section 16-2-9 (Solid Waste Fees) of the Weber County Code:

- Increases the Transfer Station general waste and construction/demolition tipping fees from \$50.00 to \$52.24 per ton. Following is a summary of the increase:
  - Weber County currently pays Republic Services \$34.22 per ton for transfer and disposal of solid waste.
  - Beginning July 1, 2025, Weber County will pay Republic Services \$35.79 per ton, or an increase of \$1.57 per ton (4.6%).
  - \$1.03 (3%) of this increase occurs annually per the approved contract, while the remaining \$0.54 (1.6%) comes from transportation related increases that Republic Services received from MBI. The total MBI increase was \$1.09 but Republic Services only passed on \$0.54 to Weber County.
  - The current Transfer Station tipping fee is \$50 per ton.
  - Beginning July 1, 2025, the tipping fee will increase \$2.24 per ton (4.5%) to \$52.24 per ton.
  - This increase covers the Republic Services cost increase of \$1.57 per ton and Transfer Station employee compensation increase of \$0.67 per ton.
  - This increase does not include funding for additional capital projects or equipment.
- Increases the fee for mattresses in excess of the first two from \$5 to \$15 per mattress. The first two mattresses are included in the tipping fee, but each additional mattress will be charged at the new rate. This is the same fee charged by Wasatch Integrated Waste Management District.
- Increases the fee for delivery of compost and wood products.

### FEE ORDINANCE AMENDMENTS RELATING TO THE WEBER COUNTY TRANSFER STATION

**WHEREAS**, Weber County received a 4.6% transportation and disposal increase from Republic Services, in addition to other personnel and operations costs related to the Transfer Station; and

**WHEREAS**, the Transfer Station is raising the general waste and construction/demolition tipping fees, among other increases for services, products, and deliveries to offset this increase; and

**WHEREAS**, after due consideration, the Board of County Commissioners of Weber County has determined to approve such fee changes; and

**NOW THEREFORE**, the Board of County Commissioners of Weber County ordains as follows:

Title 16, Chapter 2, Section 9 of the Weber County Code shall be amended to read as follows:

Dear Sean,

I am writing to notify you of the contracted transportation price increase that will hit July 1, 2025. Weber County will receive a price increase of 3.00%, plus \$0.54 of the 6% (\$1.09 increase) Republic Services received from our hauling contractor.

### SECTION THREE TRANSPORTATION AND DISPOSAL FEES

Annual Adjustment. The Parties agree that there will be no annual increase for 2020. Further the Parties agree that the T&D Fee shall be increased annually on July 1st of each year by 3%, beginning on July 1, 2021.

Current Rate. The Parties agree that the T&D Fee shall be decreased from the current rate to \$24.99 per ton beginning July 1, 2020.

Transportation Adjustments. The Parties agree that any increase in transportation costs to Contractor above 3% in any 12-month period from any transportation company or transportation subcontractor that Contractor utilizes to provide services under the Contract will be passed on to County and the rate will be increased accordingly. All previous Fuel adjustments are hereby deleted in their entirety and any fluctuation in fuel pricing will be governed by this provision. Unexpected fuel increases can be negotiated, in good faith, quarterly as necessary.

The new rate will be effective July 1, 2025.

New rate: \$35.79 (\$35.25 + 0.54)
