A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS
OF WEBER COUNTY MAKING NEW APPOINTMENTS
AND REAPPOINTMENTS TO THE RAMP TAX ADVISORY BOARD,
THE RAMP TAX ARTS AND MUSEUMS COMMITTEE, AND
THE RAMP TAX RECREATION AND PARKS COMMITTEE

WHEREAS, the RAMP Tax Advisory Board has given notice to the Board of County Commissioners of Weber County (“Commission”) in regard to certain vacancies on the RAMP Tax Advisory Board (“Advisory Board”), the RAMP Tax Arts and Museums Committee, and the Ramp Tax Recreation and Parks Committee; and

WHEREAS, after receiving applications from various individuals, the Board has made recommendations to the Commission for filling those positions; and

WHEREAS, the Commission has duly considered all applications as well as the recommendations of the Board and has determined certain individuals to be well qualified to continue service or begin service on the Advisory Board or Committees;

NOW THEREFORE, pursuant to the RAMP Tax Ordinance governing the appointment process, the Commission does hereby make the following appointments:

1. Scott Smith and Denise Green are each hereby appointed to serve a term on the Recreation & Parks Committee. These appointments will begin on December 16, 2025 and end on September 30, 2028.
2. Bret Holmes, is hereby reappointed to serve on the Recreation & Parks Committee and the Advisory Board. Dana Gibson is reappointed to serve on the Arts & Museums Committee and the Advisory Board. These appointments will begin on December 16, 2025 and end on September 30, 2028.
3. Liz Morrison is hereby reappointed to serve on the Recreation & Parks Committee and appointed to serve on the Advisory Board. This appointment will begin on December 16, 2025 and end on September 30, 2028.
4. Sylvia Newman and Jordan Brun are each hereby reappointed to serve a term on the Arts & Museums Committee. These appointments will begin on December 16, 2025 and end on September 30, 2028.
5. Kevin Burns is hereby reappointed to serve as Chair of the Advisory Board, Korry Green is hereby appointed to serve as Chair of the Recreation & Parks Committee. Jim Craig is hereby appointed to serve as Chair of the Arts & Museums Committee. These appointments will begin on December 16, 2025 and end on September 30, 2026.
