**Summary:** The Utah Department of Transportation (UDOT) previously signed a cooperative agreement with Weber County to dispose of waste from road maintenance projects at the County's Construction and Demolition Landfill. That agreement has expired and UDOT would like to sign a new five-year agreement with Weber County. Under the new agreement, UDOT will pay \$18 per ton, which is the current rate. The County's landfill operator, Moulding and Sons, will bill UDOT monthly for waste it brings to the landfill.

## COOPERATIVE AGREEMENT

THIS COOPERATIVE AGREEMENT is made and entered into this 1<sup>st</sup> day of February 2022, by and between the UTAH DEPARTMENT OF TRANSPORTATION, hereinafter referred to as "UDOT," and WEBER COUNTY, a body corporate, politic and political subdivision of the State of Utah, hereinafter referred to as "County."

### RECITALS

WHEREAS, UDOT performs regular maintenance work on State roads that produces waste from various sites in Weber County that require disposal; and

WHEREAS, UDOT wants to utilize County's current C&D Landfill to dispose of such waste; and

WHEREAS, UDOT intends to reimburse County for disposal fees under this Agreement; and

WHEREAS, this agreement is made to set out the terms and conditions where such disposal will take place;

NOW, THEREFORE, It is agreed by and between the parties hereto as follows:

1. County will allow UDOT to dump waste from State road maintenance operations collected by Maintenance Stations as needed. This Agreement shall cover only those items that the County is licensed to dispose of.
  - A. County shall accept and dispose of construction, demolition, yard, road building, land clearing, road sweepings, and other acceptable waste material delivered by UDOT to County's landfill site located at 10485 West 900 South, Ogden UT, 84404. County's Landfill is a Class VI landfill and County and its operations at such site shall conform to and be governed by:
    - (1) The requirements for a Class VI landfill as outlined in the Utah Solid Waste Permitting and Management Rules (R315-301 through 320) of the Utah Administrative Code and the Utah Solid and Hazardous Waste Act;
    - (2) Clarifications and guidance regarding such waste management rules obtained from the Utah Department of Environmental Quality or its Division of Solid and Hazardous Waste.
  - B. Prohibited wastes shall be segregated and sent back with UDOT's truck, or the entire load may be deemed unacceptable and rejected by County. For rejected loads, a "Rejected Waste Shipment Form" shall be completed by County's management personnel and provided to UDOT's Region 1 at the address in paragraph 2, and to the Weber/Morgan Health Department.
  - C. UDOT shall deliver its waste to County's landfill site. Upon arrival of UDOT's delivery vehicle at the Landfill, County's Landfill personnel shall clearly direct UDOT's driver to the appropriate place to unload. UDOT shall unload each delivery at the place directed by County's personnel.
  - D. Deliveries of waste shall be made during County's normal business hours for County's landfill site.

2. County will send an invoice monthly to UDOT Region 1 offices located at 166 West Southwell St. Ogden, UT 84404, at which time UDOT will process payment to be sent to County.
3. This Agreement will be terminated February 1, 2027 unless the parties hereto agree to extend it by written amendment prior to its expiration.
4. The fees for waste transported and accepted at County's Landfill shall be as specified in Attachment A which is incorporated into this Agreement and made a part hereof.

IN WITNESS WHEREOF, the parties hereto have caused this Agreement to be executed by their duly authorized officers as of the day and year first above written.
