

AGREEMENT BETWEEN VICOTRY SUPPLY, LLC AND WEBER COUNTY

This agreement is entered into by and between Victory Supply, LLC, a limited liability corporation ("Supplier") and Weber County, a political subdivision of the State of Utah ("County"), on the date of the last signature indicated below.

WHEREAS, the Sheriff's Office is in need of various goods and services and has advertised for a company to provide said goods and services in accordance with the county's procurement code; and

WHEREAS, Supplier submitted a bid in response to the advertisement and was ultimately selected by the County to be awarded the contract;

NOW THEREFORE, for good and valuable consideration and the mutual covenants and promises contained herein, the parties agree as follows:

- 1. Goods/Services:** Supplier shall provide the goods, and any services related thereto, identified and described on the attached **Exhibit A**, to the Weber County Sheriff's Office in accordance with the terms and conditions of this agreement.
- 2. Ordering:** The County shall purchase one or more of the goods or services by issuing a written purchase order(s) or similar appropriate written document ("Order"), each of which will be deemed incorporated into this agreement for purposes of such Order only.
- 3. Pricing:** The pricing/rates for the goods/services is contained on **Exhibit A** and shall be the delivered pricing.
- 4. Agreement Term and Extension or Renewal:** The effective period of this agreement shall be from date of execution for a period of 1 year. It is also a specific provision of this agreement that the County and the Supplier may mutually agree to renew the agreement for additional one year terms, but not to exceed an aggregate of five years. Supplier shall be notified in writing by County of the County's intention to extend the period at least sixty (60) calendar days prior to the expiration of the original time period.
- 5. Non-Exclusive:** This agreement is non-exclusive. County does not guarantee any minimum purchase other than as provided herein.
- 6. Inspection and Acceptance:** County may inspect all goods/services prior to acceptance. Payment does not constitute acceptance. Supplier shall bear the cost of any inspection/testing that reveal goods/services that are defective or do not meet specifications. County's failure to accept or reject goods/services shall not relieve Supplier from its responsibility for such goods/services that are defective or do not meet specifications nor impose liability on County for such goods/services. If any part of the goods/services are not acceptable to County, County may, in addition to any other rights it

may have at law or in equity: (1) make a warranty claim; (2) repair and/or replace the goods or substitute other services at Supplier's expense; or (3) reject and return the goods at Supplier's cost and /or reject the services at Supplier's expense for full credit. Any rejected goods/services are not to be replaced without written authorization from County, and any such replacement shall be on the same terms and conditions contained in this agreement. Supplier shall perform all services in accordance with the standard of care exercised by highly competent Suppliers who perform like or similar services.

- 7. Shipping, Taxes and Other Credits and Charges:** All pricing is F.O.B. destination unless otherwise specified. Shipments must be marked with Supplier's name, the Purchase Order number, and contain a delivery or packing slip. Supplier shall not impose any charges for boxing, crating, parcel post, insurance, handling, freight, express or other similar charges or fees. Supplier shall comply with any additional delivery terms specified herein. Supplier shall pay all sales and use taxes levied by County on any tangible personal property built into the goods/services. Supplier shall obtain a Certificate of Exemption from the State of Utah Department of Revenue prior to the purchase of any materials to be built into the goods/services and provide a copy of the Certificate to County prior to final payment.

- 8. Risk of Loss:** Supplier shall bear the risk of loss, injury, or destruction of goods prior to delivery to County. Loss, injury, or destruction shall not release Supplier from any obligation hereunder.
- 9. Invoice:** Each invoice shall include: (i) the Purchase Order number; (ii) individual itemization of the goods/services; (iii) per unit price, extended and totaled; (iv) quantity ordered, back ordered and shipped; (v) an invoice number and date; (vi) ordering department's name and "ship to" address; and (vii) agreed upon payment terms set forth herein.

- 10. Payment:** County agrees to provide payment within 30 days.

- 11. Warranty:** Supplier warrants and guarantees to County that all goods furnished under this agreement will be free from defects in workmanship and materials, are merchantable, and fit for the purposes for which they are to be used. Supplier agrees to replace the defective

merchandise within seven days of receipt of the defective goods or accept the defective goods for full credit and payment of any return shipping charges.

12. Termination: County may terminate this agreement, in whole or in part, at any time and for any reason immediately upon written notice to Supplier. In the event of such a termination, County's sole liability shall be limited to payment of the amount due for the goods/services accepted by County. Supplier acknowledges the risks inherent in this termination for convenience and expressly accepts them. Termination by County shall not waive any claims County may have against Supplier.

13. Assignment/No Third-Party Beneficiary: Supplier shall not assign or subcontract any of its rights or obligations under this agreement without the written consent of County. In the event County permits an assignment or subcontract, Supplier shall continue to be liable under this agreement and any permitted assignee or subcontractor shall be bound by the terms and conditions contained herein. This agreement is intended solely for the benefit of the County and Supplier with no third-party beneficiaries.
