**Summary:** This ordinance accomplishes the following purposes in amending Section 16-2-9 (Solid Waste Fees) of the Weber County Code:

- Removes the fees for residential solid waste collection and disposal services in Ogden Valley.
- Adjusts the fee schedule for residential solid waste collection and disposal services in unincorporated western Weber County and Uintah Highlands to account for contractual annual increases.
- Residents with one container in western Weber County will see an increase of \$1.02 per quarter and residents in Uintah Highlands will see an increase of \$0.96 per quarter.
- The total cost for each additional container in western Weber County will increase by \$1.02 per quarter and in Uintah Highlands by \$0.99 per quarter.

**WHEREAS**, Weber County reviews its solid waste fees on a regular basis, and

**NOW THEREFORE**, the Board of County Commissioners of Weber County ordains as follows:

Title 16, Chapter 2, Section 9 of the Weber County Code shall be amended to read as follows:

**WHEREAS**, Weber County reviews its solid waste fees on a regular basis, and

Sustainability in Action

7. Rates for Services; Rate Adjustments; Additional Fees and Costs.
  - 7.1 Rates for Services. The rates for all Services shall be as shown on Exhibit B, subject to the rate adjustments and additional fees and costs as set forth herein.
  - 7.2 Annual Rate Adjustments. Company shall increase the rates for all Services by three (3) percent effective on January 1 of each year of this Agreement.
  - 7.3 Cost Adjustments and Fees. Once per year, Company may increase the rates for Services as a result of increases in costs incurred by Company due to (a) increased fuel costs and (b) any third-party fees or costs that are beyond the reasonable control of Company. Changes in fuel costs will be addressed through a fuel surcharge that will use \$3.00/gallon as a baseline, with the rate going up/down by \$.03 for every \$.10 increase/decrease. The increase/decrease will be determined using the last twelve-month average. Increased third-party fees or costs that are beyond the reasonable control of Company shall be added to the rates in an amount sufficient to recover Company's increased costs retroactive to the effective date of such increase or change in cost, as well as to cover the increase going forward.
