

ORDINANCE NO. _____

AN ORDINANCE ALLOWING APPOINTMENT OF ADDITIONAL ALTERNATE MEMBERS TO THE GRAMA APPEALS BOARD

WHEREAS, Weber County has established a three-member appeals board to hear appeals of decisions made under the Government Records Access and Management Act (“GRAMA”), with one member being a county employee and two members being members of the public; and

WHEREAS, the current county ordinance requires the county commissioners to appoint two alternate members: one county employee and one member of the public; and

WHEREAS, at times, scheduling issues have arisen due to the unavailability of the members and alternates; and

WHEREAS, the county commissioners find that allowing the appointment of additional alternate members to the GRAMA appeals board would facilitate the scheduling of appeal hearings;

NOW THEREFORE, the Board of County Commissioners of Weber County ordains as follows:

1. Section 2-13-7(h)(5) of the Code of Ordinances of Weber County, Utah, is amended as follows:

Code section being amended, showing changes

(5) The county commission shall appoint at least two alternate members: at least one county employee and at least one member of the public. ~~The A~~ county employee alternate shall serve on, and chair, the board in the absence of the county employee member, and ~~the a~~ public alternate shall serve on the board in the absence of one of the public members of the board.

Amended code section

(5) The county commission shall appoint at least two alternate members: at least one county employee and at least one member of the public. A county employee alternate shall serve on, and chair, the board in the absence of the county employee member, and a public alternate shall serve on the board in the absence of one of the public members of the board.

2. Effective date and publication

- a. This ordinance shall take effect 15 days after its passage.
- b. The Clerk/Auditor’s office is directed to publish a short summary of this ordinance in the *Standard Examiner* newspaper before 15 days after the date of its passage.
