The undersigned, WEBER COUNTY ANIMAL SHELTER, as a distributee of the above estate, hereby:

1. Acknowledges receipt from SUSAN R. RIGGS, as Successor Trustee of the Joyce R. Matlock Living Trust dated August 26, 2015 ("Trust") and as Personal Representative of the Estate of JOYCE R. MATLOCK ("Estate"), the sum of \$482,347.80 as full and final satisfaction of any and all beneficial interests of the undersigned in the Trust and Estate, pursuant to the proposed distribution set forth in the Trustee's correspondence dated April 27th, 2026.

2. Acknowledges that the sum of \$50,000 is being held in reserve for the purpose of finalizing administration of the Trust, to include the payment of legal fees, accounting fees, tax preparation, compensation of the Successor Trustee, final expenses, and other closing costs. The undersigned acknowledges that the reserve is retained for administrative purposes and does not create any further beneficial interest of the undersigned.

3. Acknowledges the receipt of an inventory and accounting.

4. Accepts the distribution in paragraph 1, above as full and final payment and satisfaction of the undersigned's interest in the Trust and Estate.

5. Forever releases and discharges Susan R. Riggs,

individually and in her capacities as Successor Trustee and Personal Representative, from any and all claims, demands, liabilities, actions, causes of action, or obligations of every kind, whether known or unknown, arising out of or relating in any way to the administration of the Trust and Estate through the date of this Release.

6. This Release shall extend to and be binding upon the undersigned and the undersigned's heirs, successors, and assigns, and shall inure to the benefit of Susan R. Riggs, individually and in her capacities as Successor Trustee of the Joyce R. Matlock Living Trust and Personal Representative of the Estate of Joyce R. Matlock, together with her agents, attorneys, representatives, and any successor fiduciaries.

7. If a court of competent jurisdiction holds any provision of this Release invalid, void, or unenforceable, the remaining provisions nevertheless shall continue in full force and effect without being impaired or invalidated in any way.

8. This Release shall be governed by and construed in accordance with the laws of the State of Utah.

9. This Release may be executed in one or more counterparts, each of which shall be deemed an original and all of which taken together shall constitute one instrument.

10. The undersigned hereby acknowledges and represents that the undersigned has been or has had the opportunity to be represented by independent counsel in this matter and has read and understood all of the terms of this Release and agrees to all of its terms and

provisions.
