RESOLUTION

State Route 199†

WHEREAS, with the completion of a State Forces Project between Upalco and Blue Bell and

WHEREAS, portions of the old alignment will be inundated by the construction of the Big Sand Wash Reservoir and

WHEREAS, it has been recommended by Mr. Earl A. Johnson, District Engineer,

NOW THEREFORE, pursuant to Authority Section 12-27-12, UCA, 1953, AS AMENDED it is hereby resolved as follows:

1. That the portion of highway constructed on new alignment be designated as a part of the State System of Highways, a distance of 2.3 + - miles.
2. That the old location of State Route 199 bypassed by the relocation of State Route 199 be abandoned from the State System of Highways and revert back to the previous owner as the State did not own free title to this land.
3. That by this action State Highway System will be reduced 0.1 + - mile.
4. That the map attached herewith illustrating the action taken herewith is incorporated as a part of this submission.
