DESCRIPTION:  
Part of the Northwest 1/4 of the Northwest 1/4 of Section 17 Township 5 North, Range 1 West, Salt Lake Base & Meridian, U. S. Survey: Beginning at a point 66.0 ft. west and 274.0 ft. North of the Southeast corner of the Northwest 1/4 of the Northwest 1/4 of Section 17; thence N. 0° 22' E 253.00 ft.; thence N. 89° 38' W. 336 ft.; thence S. 0° 22' W. 209.15 ft.; thence along the arc of a 191 foot radius curve to the left 35.36 ft., the long chord of which bears N. 64° 55' 15" E. 35.31 ft.; thence N. 59° 57' E. 10 ft.; thence along the arc of a 266 foot radius curve to the right 142.76 ft., the long chord of which bears N. 74° 59' 30" E. 141.05 ft.; thence S. 89° 38' E. 13.5 ft.; thence S. 0° 22' W. 101.5 ft.; thence S. 89° 38' E. 146.0 ft. to the point of beginning.

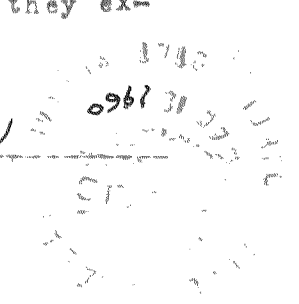
