TO WHOM IT MAY CONCERN: I, FRED W. MALAN, do hereby certify that I am a Registered Land Surveyor, and that I hold Certificate No. 1441, as prescribed by the Laws of the State of Utah and I have made a survey of the following described property:

A Part of the Northeast Quarter Section 13, Township 5 North, Range 2 West and Part of the Northwest Quarter Section 18, Township 5 North range 1 West, Salt Lake Base and Meridian, U. S. Survey:

Beginning at a point 627 feet North  $0^{\circ} 28'$  East along the section line from the East Quarter Corner of said Section 13, and running thence South  $80^{\circ}$  East 26.7 feet to the most Southerly line of Interstate Highway 80-North; thence along said line North  $37^{\circ} 14'$  West 24.5 feet to the State Road Station 911  $\frac{1}{4}$  00 and North  $36^{\circ} 16'$  West 362 feet to old fence line and a point 20 chains South along the Section line and South  $53^{\circ} 30'$  West 421.72 feet from the Northeast Corner of the Northeast Quarter of said Section 13; thence South  $53^{\circ} 30'$  West 108 feet to the centerline of 1150 West Street; thence South  $9^{\circ} 42'$  West along the center line of said road 230 feet to the North line of Froerer property; thence South  $80^{\circ}$  East 191 feet; thence South  $22^{\circ} 19'$  East 49.74 feet; thence South  $10^{\circ} 00'$  West .48 feet; thence South  $80^{\circ}$  East 266.41 feet to the point of beginning.
