MALAN, do hereby certify that I have made a survey of the following described property: as shown on the attached plat; Part of the S.W. 1/2 of Sec 23, T.6N, R.1E Salt Lake Base & Meridian, U.S. Survey Beginning at a point S $89^{\circ} 20'$ W, 2719.5 feet from the S.E. corner of said sec 23. Running thence S $89^{\circ} 20'$ W 1000.00 feet along said sec. line; thence N. $14^{\circ} 58'$ E. 733.28 feet to the South side of the County Road to Snow Basin; thence N $80^{\circ} 30'$ E, 73.04 feet along the south side of said County Road; thence North easterly along the arc of a 333 foot radius curve to the left 229.57 feet whose long chord bears N $60^{\circ} 45'$ E. 225.05 feet; thence N $41^{\circ} 00'$ E. 195.00 feet along south side of said county road; thence northeasterly along the arc of a 267 foot radius curve to the right 241.16' whose long chord bears N. $66^{\circ} 37' 30''$ E, 230.94'; thence S $87^{\circ} 15'$ E. 128.00 feet along the south side of said County Road; thence along the arc of a 333 foot radius curve to the left 64.22 feet, whose long chord bears N $80^{\circ} 07'$ E, 64.12 feet; thence S $16^{\circ} 02'$ W 588.35 feet; thence S. $89^{\circ} 20'$ E. 167.84 feet; thence S. $0^{\circ} 40'$ E. 500.00 feet to the south line of said Sec 23, to the point of beginning.
