


## SECTION 24, T6 N., R1 W., S. L. B. &amp; M., U. S. SURVEY



TO WHOM IT MAY CONCERN: I, FRED W. MALAN do hereby certify that I am a Registered Land Surveyor, in the State of Utah, and do hereby certify that the plat of COOL WATER SUBDIVISION in Weber County Utah has been correctly drawn to the designated scale and is a true and correct representation of the following described lands included in said subdivision based on data compiled from the records of the Weber County Recorder's Office and the Weber County Surveyor's Office and of a survey made on the ground.

A part of the Northwest and Northeast Quarters of Section 24, Township 6 North, Range 1 West, Salt Lake Base and Meridian, U. S. Survey: Beginning at a point on the North right of way line of the Utah-Iddaho Central Railway Company 240 feet West and 115.4 feet North of the Southeast corner of the Northwest Quarter Section, said point being 115.4 feet North of the Northeast corner of the wagonridge, thence South 70° West 241 feet; thence North 37.7 feet to the base of mountain, thence North 54° 33' East 47.3 feet; thence North 64°45' East 103.8 feet; thence North 60° East 108.4 feet; thence North 60° 28' East 108.00 feet; thence North 43°08' East 137.3 feet; thence North 52° 27' East 118.5 feet; thence North 52°4' East 119 feet; thence North 70° East 60 feet; thence North 75° 20' East 95.5 feet; thence North 87° 42' East 89.6 feet; thence North 87° 338 East 86.34 feet North 85° 23' East 165.3 feet to a point ~~40.44 ft~~ North of the North right of way line of the Ogden, Logan and Idaho Railway Company South 40.44 feet; thence along said right of way line South 55° 20' West 200 feet; thence South 59° 30' West 100 feet, South 53° 30' West 100 feet; South 67° 30' West 100 feet; South 70° West 460 feet to beginning
