



SURVEYOR'S CERTIFICATE

To whom it may concern, I, Fred W. Malan do hereby certify that I am a Registered Land Surveyor, and that I hold Certificate No. 1441, as prescribed by the Laws of the State of Utah, and I have made a survey of the following described property:

A part of the NE  $\frac{1}{4}$  Section 13, T5N R2W and part of the NW  $\frac{1}{4}$  Section 18, T5N R1W S.L.M. U.S. Survey. Beginning at a point 627 feet N. 0° 28' E. along the section line from the E.  $\frac{1}{4}$  Corner of said Section 13, and running thence S. 80° E. 26.7 feet to the most Southerly line of Interstate Highway 80-N; thence along said line N. 37° 14' W. 225 feet to State Road Station 911+00, and N. 36° 16' W. 362 Feet to the old fence line and a point 20 Chains South along the section line and S. 53° 30' W. 421.72 feet from the NE Corner of the NE  $\frac{1}{4}$  of said section 13; thence S. 53° 30' W. 108 feet to the centerline of 1150 West Street; thence S. 10° 17' W. along the centerline of said road 230 feet; to the North line of Froerer property; thence S. 80° E. 191 feet; thence S. 22° 19' E. 49.74 feet; thence S. 10° 00' W. 48 feet; thence S. 80° E. 266.41 feet to the point of beginning,

A part of the NE  $\frac{1}{4}$  Section 13, T5N R2W and part of the NW  $\frac{1}{4}$  Section 18, T5N R1W S.L.M. U.S. Survey. Beginning 1320 feet S. 0° 28' W/ along the Section line from the NW Corner of said Section 18 and running thence South 53° 30' W. 149.72 feet more or less to the Northeasterly line of Interstate Highway 80-N; thence South 34° 30' E. 360 feet; thence S. 35° 20' E. 158 feet, to the West line of State Highway U-60; thence North 15° 25' E. 548 feet more or less to the South line of Carlsen property; thence N. 74° 35' W. 244 feet more or less to a point N. 53° 30' E. 120.78 feet from the point of beginning; thence S. 53° 30' W. 120.78 feet to the point of beginning.
