

VISITING RULES:

ONLY APPROVED VISITORS SHALL BE ALLOWED IN THE VISITING AREA. EXCEPTIONS ARE TO BE APPROVED BY THE JAIL COMMANDER/DESIGNEE ON A CASE BY CASE BASIS.

PUBLIC VISITATION IS OPEN MONDAY, TUESDAY, THURSDAY AND FRIDAYS FROM 1:00 P.M. TO 8:00 P.M. AND SATURDAYS FROM 10:00 A.M. TO 8:00 P.M.

INMATES AND VISITORS SHALL COMPLY WITH WEBER COUNTY CORRECTIONAL FACILITY REGULATIONS, POLICY AND PROCEDURE.

ONLY THREE VISITORS PER INMATE MAY BE ALLOWED INTO THE VISITING AREA AT ONE TIME.

ADULT VISITORS ARE REQUIRED TO PRESENT A VALID ID. STATE, MILITARY, TRIBAL, OR OTHER GOVERNMENT IDENTIFICATIONS WILL BE ACCEPTED.

MINOR CHILDREN MAY VISIT WHEN ACCOMPANIED BY AN APPROVED ADULT VISITOR.

VISITS MAY BE SUSPENDED OR TERMINATED IF A VISITOR FAILS TO SUPERVISE AND MAINTAIN CONTROL OF ANY MINORS/CHILDREN ACCOMPANYING HIM/HER TO THE VISIT.

ALL VISITORS ARE SUBJECT TO SEARCHES AND BACKGROUND CHECKS.

VISITORS SHALL BE MODESTLY DRESSED. NO HALTER TOPS, TANK TOPS, SHORT SKIRTS, SEE-THROUGH OR OTHERWISE REVEALING CLOTHING WILL BE PERMITTED. ATTIRE DETERMINED BY STAFF TO BE UNACCEPTABLE WILL NOT BE PERMITTED.

ANY VISITOR FOUND IN POSSESSION OF ILLEGAL CONTRABAND SHALL BE DETAINED AND IS SUBJECT TO PROSECUTION, AND MAY HAVE VISITING PRIVILEGES SUSPENDED, RESTRICTED, OR REVOKED.

VISITS MAY BE TERMINATED/DENIED FOR FOUL AND ABUSIVE LANGUAGE/CONDUCT, VIOLATIONS OF VISITATION DRESS STANDARDS, OR REFUSAL TO COMPLY WITH WCCF REGULATIONS, POLICIES AND PROCEDURES, OR WHEN NECESSARY TO MEET SAFETY, SECURITY, MANAGEMENT, OR CONTROL REQUIREMENTS OF THE WCCF/CONDUCT, VIOLATIONS OF VISITATION DRESS STANDARDS, OR REFUSAL TO COMPLY WITH WCCF REGULATIONS, POLICIES AND PROCEDURES, OR WHEN NECESSARY TO MEET SAFETY, SECURITY, MANAGEMENT, OR CONTROL REQUIREMENTS OF THE WCCF.

NO USAGE OF CELL PHONES WHILE IN THE VISITATION AREA, VISITS WILL BE SUSPENDED IF VISITOR IS CAUGHT TAKING PICTURES, SHOWING PICTURES OF EXPLICIT PHOTOS OR PROVIDING A 3 WAY CALL.

INDIVIDUALS VISITING INMATES OVER INTERNET ARE EXPECTED TO DRESS AND ACT AS IF THEY WERE PHYSICALLY AT THE WEBER COUNTY SHERIFF'S OFFICE.

ALL VISITS ARE MONITORED AND RECORDED
